This course introduces post-graduate students to the theory and practice of qualitative methods -- participant observation and in-depth interviews. We begin by reading carefully and critically two qualitative studies which apply these two methods. We will then discuss the methodological and analytical strategies involved in designing and executing qualitative research by examining the logic of formulating research questions, sampling, casing, comparison, inter-subjectivity in interviews, concept formation, theoretical construction, ethical and political issues in doing ethnographic fieldwork. Students will choose a field site to conduct preliminary interviews and ethnographic fieldwork and learn to code, analyze, conceptualize and theorize from and with the data.

- 1. Attend all class meetings and participate in discussion (20%)
- 2. Submit 2 questions for discussion (**due every Wednesday noon**) and serve as discussion leader for one week's readings (20%)
- **3.** Conduct preliminary fieldwork for discussion (10%); 1-page project note **due February 26**

About the instructor Professor C.K. Lee (李靜君) is Chair Professor at the Social Science Division, HKUST. Born and educated in Hong Kong, she obtained her PhD in Sociology at UC Berkeley. She was a faculty at the Chinese University of Hong Kong and the University of Michigan, Ann Arbor, before moving to UCLA more than a decade ago. Her research interests include political sociology, protests, labor, development, China, Hong Kong, global and comparative ethnography. She is the author of three award-winning monographs: Gender and the South China Miracle: Two Worlds of Factory Women (1998), Against the Law: Labor Protests in China's Rustbelt and Sunbelt (2007), and The Specter of Global China: Politics, Labor and Foreign Investment in Africa (2017). Her articles have appeared in the American Journal of Sociology, American Sociological Review, Theory and Society, New Left Review, the China Quarterly, and Journal of Asian Studies. Her most recent co-edited volumes include The Social Question in the 21st Century: a Global View (University of California Press, 2019) and Take Back Our Future: an Eventful Political Sociology of the Hong Kong Umbrella Movement (Cornell University Press, 2019).
